- The Additions to Reserve Policy
   Current policy is from 2001. New policy is forthcoming.



Geographic Additions


Unsold Surrendered Land Additions

- Identify concerns
- Address 3rd Party Interests
- Submit required documentation

#### **AANDC HQ**

If unresolved urban/contentious concerns, make recommendations to Minister
